ITEM 230 – Reciprocal Switching

A reciprocal switch charge will be assessed on every loaded railcar that is interchanged with SVT in connection with SVT served locations at charges shown below. The rates cover loaded movement of a car in one-direction and return of empty car.

Note 1: Rates for Oversize Loads requiring clearance will be determined through Oversize Pre-Clearance Proposal listed in SVT 9000 Series. In the event a Oversize Load is received by SVT without SVT Pre-Clearance per SVT 9000 Series, car may be rejected or held by SVT under Demurrage until Rate for Oversize Load and SVT Clearance is attained.

Note 2: Rates for Articulated railcars are per Unit. See ITEM 50.

Note 3: Rates for Rail Security-Sensitive Materials (RSSM) will be determined by reaching out to SVT. In the event a RSSM car is received by SVT without written permission from SVT, SVT may reject the car or hold car under Demurrage until rate is attained. See SVT 9000 Series Glossary for full definition of RSSM.
